Westlaw Patron Access Remote **Pilot Program**



The Hawai'i Supreme Court Law Library is participating in the Westlaw Patron Access Remote Pilot Program with Thomson Reuters to provide pro se patrons (self-represented litigants) remote access to the Westlaw database.

To get access, Pro se patrons (self-represented litigants) will be required to complete a **OnePass Registration** and validate their email address before accessing the online content. To access Westlaw Patron Access Remote in the future, patrons who previously registered can click on the Westlaw Patron Access Remote registration link and enter the OnePass username and password previously created.

SCLL Certification Service



The library provides an exceptional **Certification Service**. Hardcopy materials are photocopied and authenticated as exact copies of originals maintained in the collection. Although this service has been available since the early 2000s for any physical materials in the library, its use has increased significantly over the past 10 years through word of mouth reference.

Marriages in the Philippines, where divorce is not allowed by law, can be legally dissolved with the recognition of a foreign jurisdiction divorce. The process involves submitting certified copies of the foreign jurisdictions divorce and uniform parentage act laws. For Hawai'i, that would be the Hawai'i Revised Statutes § 580 and 584.

What is a Zine?

Zines are often self-published original works of alternative literature that are disseminated in a magazinelike format. The majority of zines are printed in non-commercial tiny runs, usually "cut and pasted" text and images merged into a story, and are made by people known as "Zinesters".

How Can You Help Build the Zine Collection?

The Supreme Court Law Library (SCLL) will accept gifts or donations from library users to expand the Zine collection. Acceptance will be based on the content of the zine (s) being in line with the mission and purpose of the SCLL. The library is looking for zines that advocate for access to justice, anti-racism, Asian American issues, Native Hawaiian and Pacific Islander (AANHPI) issues, and zines that deal with legal topics generally. Our goal with this new collection is to provide our patrons with greater knowledge, appreciation and perspective on a variety of legal issues.

Original zines may be submitted in-person at the Reference Desk or dropped anonymously in the specially designated drop-box at the entrance of the library.

Gifts or donations of Zines are accepted with the understanding that they become the property of the Supreme Court Law Library and will be added to the collection at the discretion of the library.

Questions for Jenny:

I love her observations and research around wholeheartedness, empathy and making space for diverse experiences, and how we can strive for achievement and excellence when free from the burden of the unattainable and always goal-post moving concept of 'perfection,' and most importantly, by coming together in meaningful connection. My favorite fiction book at the moment is: **The Firekeeper's Daughter**, by **Angelina Bouley**. It's a heartfelt storyline of mystery and thriller that embraces the complexity of moving between indigenous and non-indigenous roots, tackles the difficult topics of generational trauma and cruelty, while also making space for a path to healing.

2. Who or What inspires you?

My mom was a working single mom from when I was a toddler through middle school, and though she remarried, she was widowed while I was in college. This meant that while she succeeded at work, she was frugal with expenses and taught me the importance of education and financial independence.

Some of the professional kernels my mom engrained into my heart: that I had to earn my own way into this world; education was key to success; and showing up early was 'on time'—anything else was late (I'm a little more gracious on this particular one, I think ha ha). She'd go on to travel to every inhabitable continent for her work as an environmental engineer and while she didn't consider herself a trailblazer, I see her as one. She had this saying: *use it up, wear it out, make it do, or do without.* It was something her mom taught her—having lived through the Great Depression—and her no-nonsense approach to getting the job done was passed down to me, and I've expanded it to include a little bit more room for compassion and flexibility. My mom passed in 2018, and I aspire every day to live up to her dedication to service in her professional work and community.




